#### HISTORICAL NOTE

The El Cubo Mining Company was one of many mining corporations which flourished in Mexico during the administration of Presdient Porfiro Diáz (1876-1911). Owned at one time by the Estate of Potter Palmer of Chicago, the company operated several gold and silver mines seven miles southeast of the city of Guamajato, Guanajuto, Mexico. Manager Irving Herr lived in Mexico with his family almost continuously from 1904 to 1932. Herr's personal papers have been published by his son, Robert Woodmansee Herr: *An American Family in the Mexican Revolution*. El Cubo is an old mine, having first been worked in the late 17<sup>th</sup> century. It still is in operation.
