**MS 1167****Campbell, John Henry, 1868-1928****Baca Float No. 3 land grant correspondence, 1914-1926****DESCRIPTION**

Correspondence, abstract of title, contracts, agreements and other legal documents relating to the Campbell's legal work regarding ownership of lands within the Baca Float No. 3 land grant following the 1914 Supreme Court's ruling that the land belonged to the Baca heirs and the entries of homesteaders were invalid and illegal.

**BIOGRAPHICAL NOTE**

Lawyer, Campbell was Asst. U.S. Attorney from 1902 to 1905, Associate Justice of the Arizona Supreme Court from 1905 to 1912, and was in private practice from 1912 to 1928. He represented clients with cattle, mining, irrigation, and real estate interests.
