Correspondence, mine reports, mine research, industry and literary publications, speeches, notebooks, photographs, and mine blueprints document the life of Courtenay DeKalb in Tucson, New York, Louisiana, and California, including his experiences in Spain, Morocco and Mexico.

BIOGRAPHICAL NOTE

Courtenay DeKalb, an internationally recognized mining engineer, was born in Loudoun County, Virginia in 1861, and held a variety of professional positions throughout his life. He was a professor of Mining and Metallurgy at the University of Missouri, professor of Mining Engineering at the University of Alabama, and he founded the School of Mines at Queens College in Kingston, Ontario. He managed several mines in California and Mexico, including the Roadside Mine in Tucson which he opened in 1921. He was the associate editor of the *Mining and Scientific Press* and was President of the Pacific Mining and Smelting Company. In 1913, he married his second wife, Frances Douglas, in Tucson. In 1919, he became a trade commissioner for the U.S. Department of Commerce, where he researched the mineral resources of Spain, Morocco, and Portugal. He was a long-time member of the National Arts Club in New York City, and published literary work, as well as scientific publications. From his first marriage he had two sons, Bozarte and Keith, and two daughters, Eugenie and Beatrice. He died in 1931 before finishing his biography of Charles III of Spain.

Frances Douglas DeKalb, an internationally recognized scholar known mostly for her translation of the Spanish writers Vincente Blasco Ibanez and Concha Espina, was born in East Cornwall, Connecticut in 1870. In 1891, she married Charles Lummis, the first city editor of the Los Angeles Times, but the two divorced in 1911. She promptly moved to Tucson and married Courtenay DeKalb two years later. She was a regular contributor for the *New York Times Book Review* and published works in such newspapers as the *Los Angeles Times*, the *New York Evening Post*, and the San Francisco Examiner. In 1933, she received an honorary doctorate of letters from the University of Arizona. In 1934, she received the Madalla de Honor de la Instruccion Publica de Venezuela. From her first marriage, she had two sons, Keith and Jordan (a.k.a. Quimu), and one daughter, Turbesé. Before she moved to California in 1963, she donated her personal library to the Romance Languages Department at the University of Arizona. She died in 1969.

SCOPE AND CONTENT NOTE

Correspondence, research materials, family history, publications, industry reports, and photographs relating to Courtenay DeKalb make up the bulk of this collection. The materials encompass mining blueprints, mining reports, Roadside Mine materials, poems, and plays written by Courtenay DeKalb. Courtenay DeKalb applied for several patents including a patent for new mining techniques and for processing molybdenum. Additionally, he produced several governmental and industry reports on mining in the western United States, Mexico, Morocco, Portugal, and Spain. There are pictures of Courtenay DeKalb with Frances Douglas DeKalb in their Tucson home and at the Roadside Mine. The correspondence ranges from personal letters exchanged between DeKalb and his family, his publishers, and his colleagues. This correspondence documents the attempts to open the Roadside Mine in Tucson, and also includes Courtenay DeKalb's opinions on World War I, nationalism, mining techniques, and published articles. There are letters from Senator Henry Cabot Lodge, Phelps-Dodge Manager John C. Greenway, Colonel William F. Cody's (a.k.a. Buffalo Bill) mining company, the Ford Motor Company, the President of Stanford University, and Madame Marie Curie.

Additionally, the collection contains family correspondence from Courtenay and Francis DeKalb's children and relatives. This correspondence includes financial advice, business relationships, and personal advice to the children. There is also material relating to Francis Douglas DeKalb, including poems and correspondence.

SERIES NOTES

Series 1, Family Papers, 1909-1931. This series includes personal correspondence, biographical material, Lummis divorce documents, Frances DeKalb's papers, and obituary notices on Courtenay DeKalb's death. 1 box, (.5 linear ft.) primarily arranged by name of correspondent.

Series 2, Notebooks and diaries, 1899-1930. This series includes notes and drafts of writings by Courtenay DeKalb. The notebooks include mining notes, literary ideas, address books and travel notes. 4 boxes, 2 linear ft. primarily arranged chronologically, though several notebooks are undated and have a topical arrangement.

Series 3 : Speeches, Lectures, and Publications, 1894-1934. This series includes speeches and lectures given by Courtenay DeKalb on a variety of subjects including World War I, the Mexican Revolution, South American History, and Mining History. This series includes DeKalb's literary output of plays, novels and poems as well as his political and technical articles. 3 boxes (1.5 linear ft.) arranged by type of writing and topically.

Series 4 : Business Correspondence, 1901-1931. Primarily business correspondence concerning DeKalb's mining work, this series also includes his correspondence concerning various publications. Correspondence from Mexico during the Mexican Revolution includes descriptions of conditions in Mexico. Principal correspondents include George M. Ryall, Victor H. Power, Louis D. Ricketts, T. A. Rickard and Richard Edmonds. Some correspondence is in Spanish. This series is primarily arranged chronologically, but several correspondents had been kept separate including H. E. Huntington, Jack Burgess, James Douglas and F. Lynwood Garrison. It should be noted that these correspondents also have more correspondence in the chronological arrangement. 12 boxes (6 linear ft.).

Series 5 : Mining and Industry Reports, 1888-1945. This series includes reports and blueprints for national and international mining areas that Courtenay DeKalb completed for various mining companies and for the U.S. government. It also includes patent applications and notes on molybdenum and DeKalb's research, reports as a consultant and inventions. 4 boxes (1.75 linear ft.) arranged topically.

Series 6 : Roadside Mine, 1915-1936. This series includes correspondence, reports, store ledgers, maps, and blueprints. This series is arranged by subject but the correspondence is arranged chronologically, with the exception of one folder of correspondence with H. E. Huntington. 3 boxes (1.5 linear ft.)

Series 7 : Frances Douglas DeKalb papers. Small amount of notebooks, correspondence and publications of Frances Douglas DeKalb. 1/2 box, .25 linear ft. arranged by format.

Series 8 : Photographs. This series is primarily portraits of Courtenay DeKalb, Frances Douglas DeKalb, and their family and friends. Also includes photographs of the Roadside mine, and other photographs of Mexico. One small album (box 29) is primarily photographs of mining operations in Superior and the Roosevelt Dam. 2 boxes (1 linear ft.) arranged topically.

Series 9 : Oversized Materials. Two scrapbooks of DeKalb's writings from 1905 to 1918. Also includes oversized blueprints, plats and diagrams on the Roadside Mine, various other mines and DeKalb's diagrams to accompany his patents. 3 boxes (5 linear ft.)
