Biographical Note

The Flagstaff Electric Light Company was incorporated by Riordan, Babbitt, Cameron, Donahue, Sisson, McGonigle and other partners in 1895. The company stock was bought out by the Riordans in 1908 and the equipment was moved to the Arizona Lumber and Timber Company sawmill. By 1913 the company had moved to West Phoenix Avenue in Flagstaff and built a new generating plant which provided its 300 customers around-the-clock (24x7) service.

Scope and Content Note

The collection is 5 linear feet in volume. It contains the original Articles of Incorporation (1895) as well as correspondence and company minutes regarding the original incorporation, etc. Also included are financial records of the company.
