MS 1365 Pioneer Hotel Records 1933 - 1963

DESCRIPTION

The Pioneer Hotel Records consists of business papers associated with the management of the hotel from 1933 to 1963. Records have been arranged into three series entailing general records, hotel audit reports, and tax information. General records include business correspondence between 1937 to 1963, banking statements on accounts, insurance claims, vouchers, and hotel receipts & billings. Additional folders document reports and correspondence to the Arizona Employment Security Commission, Arizona Corporate Commission, and the Industrial Commission of Arizona between 1935 and 1962. Hotel employee records are also present relating to tips and gratuities, bartender union dues, various wage garnishments, and vacation & bonus payments. Audit reports prepared by outside auditors provide a detailed view of the financial status of the hotel from 1934 to 1962. The final series provides various tax and assessment information in association with the Pioneer Hotel including state and federal taxes, city & county tax assessments, liquor, and property assessments. Outside items include general account ledgers for operations between 1953 and 1960 and one drawing of city block #194 showing the location of the Pioneer Hotel dated 1946.

HISTORICAL NOTE

The Pioneer Hotel located on the corner of Stone Avenue and Pennington Street in downtown Tucson was opened in 1929 and became a landmark in Tucson. Harold Steinfeld built the hotel. On December 19, 1970 a fire heavily damaged the hotel and killed 28 individuals including Steinfeld and his wife. Although redecorated and reopened the hotel closed in 1974 and was used as an office building.
