# **BIOGRAPHICAL NOTE**

Known best as a writer and researcher of Western outlaw history; Rasch was also a Lt. Commander in the U.S. Navy, archeologist, physiologist, and a technical author. Rasch authored many articles about lawlessness in the Southwest which were published in Westerners' Brand Books, Real West, True West, National Association and Center for Outlaw and Lawman History Newsletter, New Mexico Historical Review, and other publications.

#### SCOPE AND CONTENT NOTE

Research correspondence, newspaper articles, manuscripts of articles, photographs and photocopies of documents from Rasch's research primarily about crimes, lawmen and outlaws in Tombstone, Arizona and St. Johns, Arizona. The majority of the collection relates to the OK Corral shooting and related Tombstone characters including the Earps, Clantons, Frank Leslie, "Doc" Holliday, John Ringo, "Curly" Bill Brocius, and Pete Spencer. There is a great deal of material on Pete Spencer including extracts from newspapers and documents, photocopies of trial documents, and correspondence with other researchers and librarians. St Johns material includes a shooting involving the Greer Brothers and Mormon families.

Rasch's arrangement of his material has mostly been retained. The majority of the collection is arranged by name of the lawman or outlaw with each file containing research correspondence, extracts and copies of newspaper and magazine articles, and photocopies of documents. Many of the files were gathered for specific articles Rasch was working on. Several files, in particular the Earp files, also contain information about related Tombstone outlaws. For example, the Earp files also contain information about Sherman McMasters, "Doc" Holliday, and M. E. Joyce among others.

Correspondents include Dave Cruickshank, Glenn Boyer, and others. Binders of typed newspaper extracts are present for Tombstone, Tucson, and other Arizona newspapers. Most articles deal with outlaws in the 1880s. There are also photocopies of the *Commercial Advertiser*, January-May 1882, of Tombstone, Arizona. Also present is a listing and description of prisoners in the Arizona Territorial Prison at Yuma from 1876 to 1895. The photographs are mostly 1980s snapshots of grave sites, homes of former outlaws, and sites of shootings.
