BIOGRAPHICAL NOTE

Charles Moses Strauss (1840-1892), superintendant of public instruction and Mayor of Tucson (1883-1884), came to Tucson in 1879. He held many public offices and was instrumental in getting the University of Arizona in Tucson. He was married to Julia Kaufmann and they had three daughters and a son. One of their daughters was Gertrude Strauss Read, (1870-1935), known as Trudie, who married William Read in 1889. William

Selleck Read (1855-1912) came to Tucson in 1876 and owned the Fashion Saloon and was a manager of L. Zeckendorf and Company and held extensive property interests in Mexico. Trudie maintained the property in Mexico after Read's death. Read and Trudie had two daughters, Olive Read (1890-1968) and Lacy Read (1894-1966). Olive married Sidney Graf in 1913. Olive Read Graf owned a business in Los Angeles called *Olive Read Creations*. The Grafs had two children, Madelyn Graf (b. 1914) and Lawrence (b. 1917).

SCOPE AND CONTENT NOTE

The collections represents three generations of the Read and Strauss families in Tucson, Los Angeles and in Cananea, Sonora, Mexico. There is a small amount of material from Charles M. Strauss, who was the patriarch of the family. His papers do not include any of his business materials or his work as mayor of Tucson. There are personal letters from him to his wife, Julia and several documents relating to the Masons. There is even less material relating to William Read; only some letters from his children are represented in the collection.

The bulk of the material are the papers of Gertrude Strauss Read Weaver and her daughter Olive Read Graf. Both women were businesswomen and the papers include both personal and business correspondence. Gertrude Strauss Read's papers include her operation of properties in Mexico through correspondence, as she seems to have run most of it from her home in Los Angeles. Most of Olive Read's correspondence is family correspondence from her parents and from her children. The collection also includes a collection of greeting and business cards.

The collection is divided into four series:

Series one is biographical/genealogy. It is arranged according to the individual family member represented. This includes an unidentified diary from 1800 and goes through 1955. The diary is written in Hartford, Connecticut and seems to be written as a prayer, asking for mercy.

Series two is correspondence. This begins with correspondence from an Elizabeth Jones in 1833 (the relation is unknown) discussing how to divide a household. The bulk of the correspondence is to Gertrude Read Weaver and Olive Read Graf, 1896-1959.

Series three are business records. They represent William Read, Gertrude Read and Olive Read from 1903-1933.

Series four is memorabilia. The bulk of this is a collection of business and greeting cards, including a scrapbook of greeting cards, mostly undated. This series includes a folder of handwritten undated recipes.
