# MS 1417 Wilfred C. Riggs & The Arizona Molybdenum Corporation 1932 - 1950

## **DESCRIPTION**

The Wilfred Riggs Collection consists of mining reports, diagrams, photographs, and correspondence associated with the Arizona Molybdenum Corporation operating mines along Copper Creek, Arizona. Mining reports capture the status and prospects of operations at the mine from 1936 to 1938. Extensive maps and drawings outline the extent of the mining operations at Copper Creek. Two folders of photographs depict miners at work, buildings and facilities on the site, and show the outcroppings of the Molybdenite ore.

## **HISTORICAL NOTE**

W. C. Riggs was president of the Arizona Molybdenum Corporation at Copper Creek, AZ. As president of the Molybdenum Corp. Riggs presided over a series of copper-molybdenum mining claims along the Copper Creek area of Pinal County Arizona. The actual mines were first named the Copper Creek Mine and later titles changed to Childes Mine and Childes-Aldwinkle claim. In 1933 Riggs purchased six claims in the center of the mining district that had been explored by other mining concerns as early as 1908. A mill was constructed at the site in 1935 and between 1933 and 1938 over 6,454,000 pounds of molybdenite, 5,519,000 pounds of copper, 473 ounces of gold, and 19,167 ounces of silver were taken from during operations. Most of the molybdenite ore came from two major locations - the South Ore Body and the Alamo Ore Body, which, although separate at the surface, united below the surface to form one large chimney of ore.
