DESCRIPTION

Documents and correspondence concerning the effort to preserve the Rillito Race Track, 1982-1990. Includes newspaper clippings, oral histories, correspondence and documents of the Committee to Preserve Historic Rillito Racetrack, the Rillito Race Track Historic Review Committee, the JNC Corp., Pima County government and the state government. Also contains documents from the Rillito Race Track after its 1988 reopening and documents concerning the 1984 Proposition 400 to preserve the Race Track. Other miscellaneous documents and correspondence are included, along with undated color photographs of the Track before its reopening.

HISTORICAL NOTE

Originally built in 1943, the Rillito Racetrack Chute became an important center for amateur Quarter Horse racing, which is done on a straight 3/8 mile track. In 1953, an oval track was built incorporating the chute to allow for the additional racing of trotters and thoroughbred horses. Many innovations began here, such as the standardization of track length and the use of the photo electric timer, as well as the chute system itself. The first legalized pari-mutuel Quarter Horse Racing started at the Rillito. The last race took place in May of 1982. Shortly after that, an effort began to preserve the Race Track as a National Historic Site. The Committee to Preserve Historic Rillito Racetrack was formed, placing on the 1984 ballot for an initiative to make the Track the official Pima County Race Track for the next 25 years. This initiative passed. Their ultimate goal was achieved in June of 1986 with the Track's inclusion in the National Register of Historic Sites. A second committee was then formed, the Rillito Race Track Historical Review Committee, to take the necessary measures to preserve and eventually reopen the Race Track to horse racing and other community activities. On Jan. 17, 1988, the Rillito Race Track was dedicated as an Historic Site. On Jan. 23, 1988, horses were once again racing at the Rillito Race Track.
