BIOGRAPHICAL NOTE: Carlos G. Robles, a member of a pioneer family, was born in Tucson in 1904. He was the son of Bernabe Robles, a prominent land owner and cattle rancher in southern Arizona. He graduated from the University of Arizona Law School in 1929. His career included serving with the County Attorney's Office as deputy attorney and later as the County's Chief Deputy Attorney. Carlos Robles later went into private practice with partner Odin Dodd. He also served on the County Board of Adjustment from 1967 to 1970.

Carlos Robles and his wife Clementina Amado Robles had two children, Carlos G. Robles Jr. and Elva Robles Ritter. Robles died in Tucson on July 27, 1980 at the age of 75.

SCOPE AND CONTENT NOTE: The bulk of this collection consists of legal case files, including agreements, complaints, affidavits, and related correspondence. This material can be divided into three categories: private estates, divorces, and the real estate and financial business of Bernabe Robles, Carlos Robles' father, a local land owner. This material is arranged in alphabetical order according to the clients' last name. The collection is valuable in that it illustrates the legal procedures, literature and attitudes of its time. Series two is a single folder containing personal correspondence written by Carlos Robles to Clementina Amado between 1927 and 1928.
