MS 848 Webb, Anderson C. Roosevelt, Ariz. Business Ledgers 1905 - 1918

DESCRIPTION

This collection consists of 10 business financial ledgers associated with commercial enterprises at Roosevelt Arizona between 1905 and 1918. Present are cash ledgers showing total receipts for daily operations of the Roosevelt Mercantile Company and the hotel (likely named The Lodge Inn). One ledger contains company organizational documents including articles of incorporation and stockholder meeting notes for 1905. Ledger #9 contains a listing of guest names at the hotel from 1916 – 1918. One additional folder consists of three meeting notes for the Roosevelt Glee Club of Roosevelt, Arizona in 1918.

BIOGRAPHICAL NOTE

Anderson Cone Webb came to Arizona with his father's family in 1890 at the age of 6 years old. Along with his sister and brother they helped work the family cattle ranch in the Tonto Basin along Tonto Creek. He attended college at Tempe Normal School in Tempe Arizona. Cone Webb's father purchased a general store and hotel near the site of the Roosevelt Dam and the family operated the store, hotel, and ranch for many years. Cone's brother Jay operated the store and hotel. Cone Webb was elected president of the Arizona Cattle Growers' Association in 1938. In 1946 he retired to Globe, AZ with his family.
