## **BIOGRAPHICAL NOTE**

George E. P. Smith was born in Lyndonville, VT in 1874 and received a degree from the University of Vermont in civil engineering. He came to Tucson in 1900 and joined the University of Arizona faculty as a professor of civil engineering. He transferred to agricultural engineering in 1906. Professor Smith remained with the University until his retirement in 1955 and published over 100 articles during that time many of which dealt with water concerns and topics. His involvement with water issues and research featured the publication of Arizona's first water code later enacted by the state legislature in 1919. He designed the first sewage system for the University campus in 1903 and the first automatic water supply system in 1916. George E. P. Smith died March 12, 1975.
