HISTORICAL NOTE

Southern Arizona International Livestock Association (SAILA) was a non-profit organization founded in 1934, although it wasn't officially incorporated until 1957. The purpose of the organization was to improve the livestock industry in Southern Arizona and Northern Mexico. Their funding came in part from the State's agricultural allocations, but also through membership dues. Some of their programs were 4-H and Future Farmers of America, and for some time the organization owned the Rillito Race Track and the Pima County Fairgrounds.
