### MS 1334 St. Luke's In-The-Desert Records 1931 - 2003

#### DESCRIPTION

This collection contains the administrative records for St. Luke's In-The-Desert, Inc. between 1932 and 2002. Records consist of boards of directors meetings, president and director messages, correspondence, committee reports and financial summaries. Documents present reflect activities of St. Luke's In-The-Desert, Inc., St. Luke's Board of Visitors, and St. Luke's Home, Inc. Each division has a folder devoted to its history and transition of the organization in its role with the community. There are no patient/resident records and only five photographs in folder #95.

#### **PROCESSING**

The collection was processed by Dave Tackenberg in July 2008. Former MS 630 was formerly processed by Todd Mills; Riva Dean completed the finding aid in July 1999 but was integrated into this collection in October 2015.

#### HISTORICAL NOTE

St. Luke's In-The-Desert, Inc. is a Diocesan corporation, which owns the property at East Adams and First Avenue. St. Luke's-In-The-Desert Tubercular Sanitarium was opened by the Rt. Rev. J. W. Atwood, Bishop of the Protestant Episcopal Missionary, District of Arizona, in February 1918. Its purpose was to provide hospital and convalescent care for men of limited means. The sanitarium was built and operated with private funds.

The Lady Board of Visitors was formed by volunteers to visit patients and provide funding assistance & furnishings for the St. Luke's Sanitarium. The first fund raising was a Silver Tea, which became an annual tradition with the organization for over 40 years. In 1919 a Ball was added as another fund raising activity and in 1923 it became a yearly function under the name *Baile de los Flores*.

In 1969, the Chest Disease Clinic at the University of Arizona Medical Center was started with seed money from the St. Luke's Board of Directors, volunteer time, and organization donations. The Clinic was completed in 1975. With the decreasing need for a sanitarium the St. Luke's Board of Directors, the Junior League of Tucson, and the Board of Visitors converted the facility to providing supervisory care for women of limited means in 1980. The new facility became known as St. Luke's Home.

#### SCOPE AND CONTENT NOTE

The St. Luke's In-The-Desert, Inc. Collection consists of administrative records associated with the organization from 1932 to 2003. The collection contains records for all three divisions of the organization. Various executive, board, committees, and funding documents are present. The collection has been divided into three series to focus on the three divisions within St. Luke's In-The-Desert, Inc.

Series 1 consists of the records associated with the over-arching organization of the St. Luke's In-The-Desert, Inc. This portion of the institution, often referred to as "the corporation", provides overall guidance and direction to the organization. This series commences with a folder highlighting the history and the various transitions that have taken place including its work as a sanitarium, association with the University of Arizona Medical Center, and its transition to providing a shelter for women of limited means. The series contains annual statements, trustee and board of director meeting notes, staff organization, and membership listings. Various committee activities, reports, and responsibilities are included as well as clinic summaries and reports from 1969 to 1978. Financial information including some budget, treasurer reports, checkbook stubs, and investments are present for the early 1990s. Newspaper articles of various events and activities are located in folder #96 and highlight the years 1973 to 1981.

Series 2 focuses upon records of the support organization primarily staff by volunteers, which assists patients and provides fundraising support for the organization. Again the first folder provides some history associated with the St. Luke's Board of Visitors and is followed with folders highlighting by-laws, policies, and constitution of the organization. Yearbooks published by the Board of Visitors for the years 1966, 1992, and 1995 to 1998 are very informative of the activities, history, and internal organization of this division. Additional folders contain the president's annual reports, which are very useful for understanding the activities and challenges from 1935 to 2002 (not all years present). Executive committee meeting notes, general membership meeting summaries, and committee reports provide a gauge of the scope of activities of the volunteer organization. Of special note in this series are folders containing information on the fundraising activities supported by the Board of Visitors including the Annual Luncheons and the Baile de los Flores events from the late 1940s to early 1990s.

Series 3 provides information on St. Luke's Home, Inc. and its transition from a sanitarium to a shelter for women. Folders with historical summaries, by-laws, and articles of incorporation are included. Some personnel listings are present but contain only names associated as staff members or volunteers. Annual reports, executive director's reports are present from the early 1980s and late 1990s. Executive committee meeting reports and board of director summaries are present for various years from 1980

to 2001. A supervisory care manual, state regulations and guidelines for health care facilities, and state health care visits (1980-1981) are contained. Admissions policies, house rules for residents, a sample application, and property listings are also present.

Box 16 contains two large ledgers with financial accounts of the Board of Visitors with reference to fundraising events and activities 1943 to 1981. Also included as oversized outside items are five scrapbooks comprised of newspaper clippings, programs and some correspondence, the collection documents the fundraising efforts of the group for St. Luke's in the Desert, a tubercular sanatorium in Tucson.
