DESCRIPTION

Ledgers with limited identification, some appear to be related to existing AHS collections while others are not so easily connected. These were apparently grouped together at some time in the past for convenience.

BIOGRAPHICAL NOTE

The Cash Journal in folder 1 is believed to relate to the business of William A. Julian, Tucson mayor, came to Tucson in 1899 from San Diego. He opened a plumbing and heating business with his brother, George. The ledgers in folders 2, 3, and 7 are believed to relate to investments of Mose Drachman including the company of Lee, Drachman & Pryce (Mose Drachman, Frank Lee, and William Pryce) ca. 1905-1911, involved in land development, subdivision planning and lot sales in Tucson; and Arizona Improvement Company (Mose Drachman, J. W. Forgeus and Judge William Sawtelle), ca. 1907-1934, also involved in real estate holdings in the Tucson area.
