BIOGRAPHICAL NOTE

Dan Williamson, Arizona State Historian, came to Arizona in 1884 and worked as an agent at Bowie Station where he witnessed Geronimo's exile to Florida in 1886. He served as quartermaster clerk at San Carlos from 1884-1896 and was involved in mining activities near Globe. In 1897, he was elected sheriff of Gila County and also served as U. S. deputy marshal. In 1907, he was elected Gila county treasurer. He was state historian from 1929 to 1931.
