<b>Abstract</b>	Contains the business records of the Arizona Lumber and Timber Company as well as subsidiary and predecessor organizations including the: Ayer Lumber Company (aka: Ayer's Mill), which became the Arizona Lumber and Timber Company after being purchased by Denis M. Riordan; the Riordan Mercantile Company (company store of the Arizona Lumber and Timber Company); the Arizona Supply Company; the McKay Cattle Company; the Black Cattle Company; the Greenlaw Lumber Company (The Riordans bought controlling interest in 1897); the Spangler Sheep Company; the Howard Sheep Company; the Central Arizona Railway Company; the Flagstaff Electric Light Company; and the Flagstaff Community Hotel. All records are ca. 1881 to 1950.

### Biographical Note

The Riordan family first established themselves in Flagstaff, Arizona in 1884 when the oldest of three brothers, Denis Matthew ("Matt") Riordan, became general manager of the Ayer

Lumber Company (established in 1881 following the demand for railroad ties for the Atlantic-Pacific rail line project). In 1887 Denis ("Matt") Riordan bought the Ayer Lumber Company. He changed the name of the company to the Arizona Lumber and Timber Company, and his brothers Timothy and Michael Riordan helped run the operations. By 1893 (1897?) Denis ("Matt") Riordan had sold his interests in the Arizona Lumber and Timber Company (AL and T) to his brothers Tim and Mike and general manager Frederick W. Sisson.

From the time they came to the area the Riordans were civic leaders in Flagstaff, establishing such institutions as the first electric company (Flagstaff Electric Light Company), the first library, literary clubs, and the Lake Mary Reservoir (named after Tim's daughter).

In 1933 the Riordans sold their interest in the Arizona Lumber and Timber Company to I.B. Koch, one-time Flagstaff mayor. Timothy A. Riordan continued to serve on the company board of directors until his death in Los Angeles, California, 1946. Michael J. Riordan died following surgery in Minnesota, 1930. Denis M. Riordan died at his San Francisco, California home in 1928. Blanche Riordan Chambers, daughter of Michael J. Riordan, was the last member of the Riordan family to live at the Riordan Mansion (Kinlich). She died in 1985, leaving the mansion to the Arizona State Park system (Riordan Mansion State Historic Park).

## Scope and Content Note

Contains the business records of the Arizona Lumber and Timber Company (formerly Ayer Lumber Company, aka: Ayer's Mill), as well as subsidiary and predecessor companies including: the Ayer Lumber Mill (which became the Arizona Lumber and Timber Company after being purchased by Denis M. Riordan), the Riordan Mercantile Company (company store of the Arizona Lumber and Timber Company), the McKay Cattle Company, the Black Cattle Company, the Greenlaw Lumber Company (which the Riordan financial empire gained controlling interest of in 1897), the Spangler Sheep Company, the Howard Sheep Company, the Central Arizona Railway Company, the Flagstaff Electric Light Company, the Arizona Supply Company, and the Flagstaff Community Hotel. The records fall within the time period of 1881 to 1950.

These records represent some of the most detailed and extensive business related materials associated with economic development in the Northern Arizona region. The broad range of business interests represented by the collection (and the associated, Riordan Family Collection, AHS #4) reflects the story of relationships between the lumber industry and the railroads; labor and management; politics and capitalism; infrastructure and community development; and even the importance of social relationships among the capitalist class (ex: Riordan and Babbitt joint business interests; Riordan and Babbitt marriages into the wealthy Metz family, originally from Cincinnati, Ohio).

[Note: Many of the materials from this collection survived a fire at the Riordan Office Building where they were originally stored. Therefore, researchers should be forewarned that some documents may be brittle and may also have carbon residue (soot) from smoke damage.]

The history of the Riordan financial holdings begins when Denis M. Riordan (initially the manager of Ayer Lumber Company) buys out the original owner (in 1893) and renames the company the Arizona Lumber and Timber Company. In turn, the Greenlaw Lumber Company was ostensibly an independent venture. However, Michael J. Riordan is listed as secretary of the company twelve years prior to the Arizona Lumber and Timber Company officially buying out Greenlaw's interest in the company (Riordans had in fact bought controlling interest in 1897). The McKay Cattle Company, Howard Sheep Company, and Black Sheep Company records all use Arizona Lumber and Timber Company envelopes for their respective financial records. It there seems likely that most of the subsidiary companies, and the resulting records, were always part and parcel of the Riordan family financial holdings. Certain companies, such as Flagstaff Electric Light Company, were initiated by Riordans along with other local capitalists, and subsequently bought out by the Riordans.

The records herein include: correspondence (small amount); monthly statements; paid bills and receipts; check vouchers; legal records; payroll records, time slips; log tallies in the mill; inventories; sawmill reports; filled orders and shipment records of the various Riordan family ventures.
