DESCRIPTION

Collection consists mainly of the financial records of the Control Mine Company. The company's profits and losses are documented thoroughly as are its taxes and business accounts. The Control Mine Company's bank account with the Southern Arizona Bank and Trust Company is also largely intact within the collection. In addition to financial records, there is also some company correspondence.

HISTORICAL NOTE

The Control Mining Company was located on Mt. Lemmon at the lowest control road on the North side of the mountain, hence the name. Until the completion of the Hitchcock Highway on the South of the mountain in the late 1940s and early 1950s this was the only road to the cabins and facilities on the mountain. The company's mine was actively mined from 1939 until the summer of 1943. The mine mainly produced copper, though some silver and gold ore was processed. The Control Mining Company was headquartered in Tucson and had stockholders around the country.
