RECORDS, 1904-1924**

**DESCRIPTION**

Official court records from the Globe District Court in Gila County, Arizona. These records are incomplete and are related only by being tried in the Globe District Court. Records include cases involving various mining claims, property disputes, railroads and assault.

**HISTORICAL NOTE**

Gila County was created in 1881 and placed in the Second Judicial District of Arizona. In 1903, it was transferred to the Third and in 1905, it was moved to the Fifth. Globe is the County Seat and was a mining town, with Old Dominion Mine being the largest employer.

Provenance is unknown.

## SCOPE AND CONTENT NOTE

This collection consists of an incomplete record of court cases from the District Court in Gila County, located in Globe. The court records cover a variety of topics and do not seem to have any relationship to each other. The topics include mining claims in the Globe area, assault, attempted murder and property disputes. There are several cases involving railroads, e.g. Gila Valley Globe & Northern Railway and the Arizona Eastern Railroad. The records cover the time period from 1904 to 1924, but it is unknown how they came to be separated from other Globe District Court cases.
