DESCRIPTION

This collection consists of four boxes of material from the Z.C. Prina family of Safford, Arizona. Two boxes contain letterbooks relating to the various business correspondence of Prina. The remaining material consists of personal papers and family photographs.

The letterbooks were donated by Hazel Prina in 1986. Remaining materials were donated by other family members in 1989.

The bulk of the collection was processed by Adelaide Elm and Mona McCroskey in August of 1989. Accessioning of photos and production of the finding aid were done by Maureen Garmon, a Graduate Library School intern, under the supervision of Deborah Shelton, photo librarian and Rose Byrne, archivist.

BIOGRAPHICAL NOTE

Z.C. (Zefferino Ceria) Prina was born in Italy in 1862, emigrating with his father to Galveston, Texas in 1871. He went to work as a cowboy at a very early age on a ranch near Austin. Subsequently, Prina worked his way through Texas and New Mexico, arriving at Willcox, Arizona in 1884. In Cochise County he worked as a horse breaker for Col. Henry Hooker on the Sierra Bonita Ranch, and then owned a ranch at Pantano. He moved to Safford as foreman of the Sun Flower Canal Company, a Chiricahua Cattle Company holding in the area.

In 1887 Prina married Martha (Mattie) Wanslee, a native of Navajo County, Arizona. In the same year he resigned his position with Chiricahua Cattle Company and started his business career by purchasing a one-third interest in the Safford Flour Mill from J.T. Owens, and a one-third interest in Blake's Hardware Store.* Both businesses were located at 102 East Eighth Street in Safford.

prina sought orders from prospective customers in surrounding communities. In 1899 and 1900 he carried on the business in the name of Prina & Pursley. His partner, James C. Pursley, was a native of Tennessee who arrived in Arizona in 1878. Pursley was another of the Chiricahua Cattle Company founders and a stockholder and officer of the Bank of Safford. (Pursley remained in the Safford area until his move to Long Beach, California in 1906 where he died in 1937 at the age of 84). The frequency and size of bank

deposit transmittals in the letterbooks indicate the success of the Prina & Pursley partnership.

In 1901 Prina formed a partnership with George A. Olney. Olney, born in 1861 in Burnett, Texas, came to Arizona and became involved in many enterprises in the 1880's. ** Prina & Olney ordered equipment and supplies for their expanding business from points as far distant as Los Angeles, Chicago, and Kansas City, as well as from merchants in Tucson. The partners were also involved in the buying and selling of livestock, and they continued to bid on contracts for the furnishing of supplies to the San Carlos Indian Agency.

It was around this time that Prina received his first formal education. He moved to Los Angeles to study business at Woodbury College. Upon his return to Safford, Prina devoted himself to the management of Safford Ice & Creamery Company, a concern owned by Prina & Olney. Orders for bottles, seals and equipment were placed as sales of butter and other dairy products increased. The dairy herd increased to around forty head, and Prina was also raising cotton on about 135 acres of land north of Safford.

From roughly 1904-1912, George Olney became even more involved in civic and political activities, eventually selling his interest to Prina and moving to the Salt River Valley. Prina carried on the Safford business. In 1904, hay was an important item of trade, the Ice & Creamery Company was doing well, and Prina & Olney had added the Canaea Consolidated Copper Company in Sonora, Mexico to their customer base. Prina continued to engage in the sale of cattle and

horses. From 1906 to 1912, he and Olney owned the Hat Ranch, ranging between Eagle and Little Bonita Creeks. Prina was also importing registered Jersey cattle from Wisconsin to improve the dairy herd, and for sale to other Gila Valley dairymen.

In about 1913, Prina went into the auto sales business for Michigan Motor Company, handling the "Mighty Michigan 40." One of his agents in Tucson was F. Ronstadt Co., described by Prina as "one of the most reliable firms in the state" when it came to maintenance and service. Car sales were lucrative enough for him to hire a salesman and offer an agency to the International Motor Car Company in Douglas, effective when he or his agent were unable Around the same time, Prina purchased the to cover the area. William Tuttle Ranch at the confluence of the Black and White Rivers in association with Harley Martin who managed the outfit. A part of their range was covered by a grazing permit on the San Carlos Apache Indian Reservation. Eventually, Prina bought out Martin's interest and "partnered up" with Charles Solomon and Adolph Ferrin, other prominent Gila Valley cattlemen, incorporate the Bonita Creek Land & Cattle Company. Prina sought a loan for the purchase of cattle from his old friend and partner, J.C. Pursley, then in Long Beach. Prina's later correspondence increasingly involves matters related to the cattle business, although he continued to operate the dairy and actively bid for San The last letters in the collection Carlos supply contracts. indicate that Prina was doing well financially, purchasing stocks and bonds and making payments on notes. They end abruptly on September 9, 1918.

Z.C. Prina was a patriotic Graham County pioneer. He served as mayor of Safford for two terms, and as a supervisor and highway commissioner. He expressed an interest in flood control measures as early as 1915, promoted the selection of Safford as the county seat, and wrote letters supporting O.B. Lancaster in the 1918 sheriff's race. He was a charter member of the Safford Masonic Lodge, and a member of the Solomonville Knights of Pythias. Prina died in an automobile accident in 1922 at the age of 60.

* John Blake, in partnership with J.T. Owens, established a flour mill in Safford, Graham County, Arizona in 1894 under the name of John Blake & Company. The first recorded transaction was a cordwood quote to the Gila Valley, Globe & Northern Railway. Blake and Owens solicited consignment sales at the outset, but were soon offering quotes on hay, flour, barley and hogs. They had to turn down an early order for rolled barley because they lacked a rolling mill. (Later, Blake was remembered as owning the largest roller mill in the territory.) Customers of Blake & Company included the Copper Queen Mining Co. in Bisbee, the San Carlos Indian Reservation and the Old Dominion Commercial Company in Globe. Blake also managed the Chiricahua Cattle Company which conducted business with many prominent southern Arizona ranchers.

As he prospered, Blake purchased a wagon, disc, rake and other farm machinery for use on his ranch at Fort Thomas, and diversified his inventory by adding such items as lumber and hardware. He also owned shares in the Montezuma and San Jose Canals. He negotiated with the railway for a right-of-way across his property in exchange for the installation of a culvert, and bargained for a spur railroad line to his Safford property.

** Olney was a freighter at Safford, deputy sheriff at Clifton in 1886, a rancher at Solomonville, a director of the Gila Valley Bank, sheriff of Graham County for two terms, and served as a delegate to the 20th Territorial Legislature in 1898. Olney owned a general store in Solomonville before his association with Prina. Eventually, Olney bought a home in Phoenix and a ranch in Laveen, and became a director of the Valley National Bank. At the time of his death in 1927, George Olney was eulogized as a pioneer in the

business development of Tucson and Arizona.

SCOPE AND CONTENT

Series I-VII of the Z.C. Prina Collection consist of two

letterbooks from the flour mill business of John Blake & Co. (1894-1896), and subsequent businesses operated by Z.C. Prina and his partners from 1889 to 1918: Z.C. Prina Co., Prina & Co., Prina & Pursley, Prina & Olney, Safford Ice and Creamery Co., and Prina Motor Sales.

Book One includes letters from John Blake and James T. Owens, his partner, to various customers and business associates, including the Chiricahua and Tuttle Cattle companies; Old Dominion Commercial Company; the Copper Queen Consolidated Mining Company; territorial legislators; pioneer cattlemen J.V. Vickers and Walter Vail; and agents at the San Carlos Apache Indian Reservation.

The content of the letters deals mainly with orders and quotes for flour, corn, hay, livestock, and other commodities sold by the business. Also referenced are data relating to shipments on the Gila Valley, Globe & Northern Railway, and equipment orders. Itemized deposit transmittals to the Consolidated National Bank in Tucson reflect the prosperity of John Blake & Co. and provide a record of its customers.

In 1889 the business was acquired by Zefferino C. Prina, who operated it with partners James C. Pursley (1898-1900) and George Olney (1901-c.1912). Prina sent commodities quotes to potential customers and, again, bank deposit transmittals evidence the success of the growing business. He purchased a steam generator, added lumber to his inventory, and installed an ice plant in 1900. By the time the business became Prina & Olney in 1901 it was an agent for Pabst Brewing Company. The business ordered fuel from

Standard Oil in Los Angeles and Santa Fe Fuel Co., and a boiler from El Paso Foundry & Machine Co.

The correspondence in Letterbook One reveals that in 1906 the dairy was productive enough to order equipment and establish the Safford Ice and Creamery Company, which Prina operated as manager, continuing his partnership with George Olney. Quotes for sweet cream, milk and butter were mailed, and separators and modern machinery were acquired to update the daily operation.

collection One Letterbook of the overlaps Book Two chronologically. It contains letters from Prina & Olney from 1904 to c.1912 when Olney's political and ranching activities took him to Phoenix; letters from Safford Ice and Creamery Co.; and, beginning in 1913, letters from Prina Auto Sales. Prina & Olney continued to contract with San Carlos agents. Hay was a big sales item at that time, and the company also engaged in the buying and selling of salt, steer and horses. Competent help at the dairy was hard to come by and Prina was frequently in the market for a good milker or dairyman. He corresponded with prospects as far away as Carthage, New York, and even wrote for recommendations from the Free Municipal Labor Bureau and the Murry & Ready employment agency in Los Angeles.

Letterbook Two also contains letters (1913) from Prina Auto Sales, one of the early auto agencies in Arizona. Prina dealt with the Michigan Motor Company in Kalamazoo, and one of his dealers was F. Ronstadt Company, Inc. in Tucson. Prina's sales territory covered southern Arizona. Prina hired a salesman and offered a

dealership to the International Motor Car Company in Douglas. Prina's diversified interests also included the ownership of a cattle ranch in partnership with Harley Martin, whose interest Prina eventually bought.

The printed materials of Series VIII of the collection consist of research notes and photocopies from Graham County, newspaper clippings, genealogy, and the death notice of Z.C. Prina.

Series IX contains legal records and documents from the period to 1936 (settlement of Z.C. Prina estate). Series X documents pertain to real estate transactions of Martha Prina in Maricopa County, and property ownership of other family members, from 1935-1969, as well as ephemera.

Series XI contains photographs from the Prina, Wanslee, Stuermer and Stanley families as well as some photographs of the Safford area.

The letterbooks comprising the Z.C. Prina Collection are significant in that they evidence the connections among some of the Gila Valley's early cattlemen and pioneer citizens. They document the presence in Safford of some of the Territory's first political leaders, as well as giving us a look into the operation and growth of a small business in Arizona at the turn of the century. In documenting the transactions of these business activities, the letterbooks are an important addition to the small amount of materials now available. They are in unstable condition due to their age and the fragile nature of their composition. The covers are cardboard with some leather trim, and show water, dirt and some

mold damage. The bindings of both books have deteriorated and are barely attached. The condition of the letters on tissue pages varies greatly, from good to illegible. They also show a good deal of water damage, as well as fading and tearing. In an effort to conserve the originals, they have been interleaved with acid-free paper and calendared as to page, date, address and subject. Researchers may refer to the calendar and then, if necessary, go directly to the desired original page without leafing through the entire book.

Another letterbook, as well as papers and artifacts relating to the business life of Z.C. Prina and his family, are in the collections of the Graham County Historical Society in Safford, Arizona.
