The collection of Gustavus A. Streitz, U.S. Deputy Mineral Surveyor and Director of the National Bank of Arizona in Phoenix, includes survey works on canals, mines and roads. The collection also includes works and papers of Harry E. Jones, Surveyor, including military records relating to his service in the Philippines as well as business and insurance papers of a personal nature.
