**DESCRIPTION**

Small collection of primarily township and range maps showing ownership of property, and mostly maps created by M. E. Leverich, Land Attorney, ca. 1915. There are a few maps, created by others, dated from the 1880s and 1900. These were formerly located in the Library's map collection but were gathered together here for improved access.

**HISTORICAL NOTE**

M. E. Leverich was a woman attorney who began a land law practice in Arizona about 1901 and handled land sales for the government as its agent until 1916 when the practice was taken over by John Page.
