### HISTORICAL NOTE

Founded in 1903, as a state affiliate of the American Bankers Association, the Arizona Bankers Association operated like other trade organizations by promoting the interests of banks and bankers. The association provided a forum for education and dissemination of information, and by supporting community charities such as the 4-H.

Morris Goldwater was secretary of the organization from 1906 until the late 1930s. The collection contains correspondence, business manuals, minutes, and bound convention proceedings from the Arizona Bankers Association conventions.

### SCOPE AND CONTENT NOTE

This collection is from the records of the Arizona Bankers Association consisting of 6 boxes of documents arranged in series: (1) Minutes of the Association, 1931-1935; (2) Correspondence and reports, 1928-1936; (3) Manuals and pamphlets, 1935-1936; (4) Proceedings of the Arizona Bankers Association, 1903-1930.
