DESCRIPTION

Board minutes, financial statements, property deeds, membership lists and profiles, church bulletins, newsletters and histories, scrapbooks and photographs, and a small amount of correspondence produced mostly during the last hundred years of the First Congregational Church operations. Board minutes, annual reports, and church bulletins are present beginning in 1916, 1929, and 1903 respectively. Most other materials were created more recently.

HISTORICAL NOTE

The First Congregational Church was organized in 1881. Its first building, purchased from the Presbyterians, was located at Courthouse Plaza in downtown Tucson until 1916. In 1915, the congregation voted to move to the University area on the corner of Second Avenue and Third Street and the first building was first sold to the City of Tucson, and then demolished. The North Second Avenue church building opened on January 30, 1916. It was designed as a replica of the first building except that it was made of brick. Additions and remodeling occurred throughout the following years and adjacent lots were purchased for various expansion plans. In 1959, members voted to build a new church to face University Blvd (formerly Third Street). This required the purchase of the Altus Lodge and the Black home on University. The church was completed in September 1960. In 2000, the property was sold to a developer and the congregation moved to several locations over the next ten years before it disbanded in 2011.

SCOPE AND CONTENT NOTE

Board minutes, financial statements, property deeds, membership lists and profiles, church bulletins, newsletters and histories, scrapbooks and photographs, and a small amount of correspondence representing the operations of the First Congregational Church. There are Articles of Incorporation from the original church, dated 1881, as well as later versions. Board of Trustee minutes, from 1916-2005, concern finances; building acquisition, remodeling, and maintenance; and personnel and membership issues. Deacon's committee minutes are also present from 1954 to 1974. In some years, the minutes include correspondence and other committee reports. Annual reports are primarily financial but some years also include committee reports. There are gaps in every type of record. Missing years were not present at the time of processing.

Highlights of the collection include a 1909-1910 cookbook with members' recipes; notes concerning the use of a vacated parsonage as a hospitality house for men enrolled in the Navy Officer's Training Program at the University of Arizona during World War II; and mentions of 1950s housing and support for American Indian students, primarily Tohono O'odham students, at the church-owned Amerind Lodge at 610 E. Second Street. Other materials describe the organ built by David McDowell from original parts of historic church organs. The Women's fellowship supported the Arizona Childrens Home, migrant families in farm labor camps, the creation of the Community Food Bank, the local chapter of Habitat for Humanity and many other concerns.

Church leaders and members include many of Tucson's pioneer families and University of Arizona faculty. These include Estelle Buehman, Helen d'Autremont, Imogene Myrland, Edwin Carpenter, Mary Estill Caldwell, Douglas and Alice Holsclaw, Robert Forbes, G. E. P. Smith, Victor and Mary Kelley, Muriel Upham, Fred Enke, A. V. Grossetta, Rollin T. Gridley, John M. Sakrison, and many others. Photographs are present of several members including Mary Caldwell, Douglas and Alice Holsclaw, and Mary Kelley.
