BIOGRAPHICAL NOTE:

Everett E. Ellinwood, noted Arizona jurist, was born July 22, 1862, in Rock Creek, Ohio. Upon receiving a law degree from the University of Michigan in 1890, Ellinwood moved to Flagstaff, Arizona Territory to open a practice. In 1893, President Grover Cleveland appointed him United States District Attorney to the territory, a position he held until 1989.

After his tenure as district attorney, Ellinwood resumed private legal practice and had offices in Flagstaff, Tucson, Prescott, Bisbee, and Phoenix. In addition, he worked as an attorney for the El Paso and Southwestern Railroad and the Phelps Dodge Corporation, was a member of the Arizona Constitutional Convention in 1910, belonged to the American Bar Association and the Arizona State Bar, and served as president of the Phoenix National Bank and Phoenix Savings and Trust Company. Committed to serving his adopted state, he launched an ill-fated campaign against incumbent Governor G.W.P. Hunt in the 1926 Democratic primary. Ellinwood ran on a platform of resolving the Colorado River controversy, strengthening the state's banks, and eliminating waste in state government. With an interest in the state's educational needs, he served as president of the Board of Regents from 1923 to 1927, and again from 1933 to 1941.

E.E. Ellinwood married Minnie L. Walkley, also a native of Rock Creek, in 1886. They had two children, Cornelia Ellinwood Morris and Ralph Everett Ellinwood. Mrs. Ellinwood passed away in 1932, and he married Hazel Nesbit the following year. On August 8, 1943, the senior Ellinwood died at the age of 81.

Ralph Ellinwood was born August 9, 1893, in Flagstaff, Arizona Territory. He benefited from a private education, attending boarding schools in California and New Hampshire before graduating from the Montclair Military Academy and, later, Amherst College.

In his junior year at Amherst, the United States declared war on Germany and the Younger Ellinwood enlisted in the American Field Service. He sailed to France in June, 1917, to serve with an ambulance unit attached to the French army. Captured by the Germans in May, 1918, Ellinwood spent the remainder of the war as a prisoner. Upon returning to the States in 1919, he recounted his experiences in Behind the German Lines, which he paid to have published the following year.

Forgoing a career in law, Ralph Ellinwood pursued newspaper work, earning a B. Lit. degree from the Columbia School of Journalism in 1921. The same year he married Clare Rounsevell, whom he had met while going to school in California. Born June 29, 1896 in Cuba, New York, Clare served overseas during World War I, stationed in France with the U.S. Army Base Hospital 20 as secretary to the commanding Officer.

Living briefly in Bisbee and Tucson, the Ellinwoods moved to California where Ralph worked as a telegraph editor of the "Sacramento Union". They returned to Tucson in November, 1924, when Ralph Ellinwood and William R. Mathews purchased the "Arizona Daily Star" from the Phelps Dodge Corporation. Ellinwood served as editor while Mathews worked as business manager.

On August 30, 1930, Ralph Ellinwood suffered a fatal heart attack. After her husband's death, Clare took an active role in running the Newspaper. Besides being a contributor to the "Star", she directed the policies of the paper's women's department away from merely society news to coverage of more important women's issues. She remained co-publisher and half owner from her husband's death until 1965. Among her many civic activities, Clare Ellinwood supported the Nature Conservancy and served as a trustee for the Arizona-Sonora Desert Museum. She died January 1, 1989.

Ralph and Clare Ellinwood had three children: Thomas, born in 1922; Betsey, born in 1924; and John, born in 1925. Thomas followed in his father's journalistic footsteps, working as both an illustrator and executive editor for the "Arizona Daily Star".

SCOPE AND CONTENT NOTE:

The Ellinwood papers consist of twenty-one boxes (10.5 cubic feet) arranged in twelve series: (1) Correspondence, 1889-1982; (2) Published Material, 1906-1971; (3) Unpublished Material; (4) Legal Records, 1892-1916; (5) Archaeological Expedition Material, 1923-1924; (6) Campaign Material; (7) Family Histories; (8) Miscellaneous Material, 1890-1954; (9) Photographs; (10) Postcards; (11) Scrapbook Material; and (12) Certificates.

This collection contains numerous correspondence from the Ellinwoods and Rounsevells, two very prolific letter-writing families. However, the primary correspondents are Ralph and Clare Ellinwood. The Ellinwood letters are rich in biographical material.

Although the Rounsevell contributions do not pertain directly to Arizona History, they too contain valuable biographical information. Clare Rounsevell Ellinwood came from an interesting pedigree. Her paternal grandparents, George and Elizabeth Rounsevell, were political and social activists who supported progressive and socialist causes. Kate C. Rounsevell (later Johannessen), Clare's mother, served overseas during World War I with the Y.M.C.A. Her father, Nelson Rounsevell, was founder, editor and publisher of the "Panama American" newspaper, and pursued many other business ventures throughout his life.

Series One, Correspondence, 1889-1982, contains the private and public letters of the Ellinwood and Rounsevell families. Notable among the Ellinwood material are letters from Ralph to his family while serving overseas in World War I. When news of Ralph's internment reached the States, the elder Ellinwoods were inundated with sympathy letters from family and friends, including William Brophy, Michael Riordan and Senator Marcus Smith. Letters between Everett and Ralph Ellinwood, as well as Ralph and newspaperman Bart P. Guild of the "Bisbee Review", provide insight into the subsequent purchase of the "Arizona Daily Star". Following her husband's death, Clare Ellinwood received numerous telegrams and sympathy letters, including regards from Senator Henry Ashurst, G.W.P. Hunt, and Edith Kitt of the Arizona Pioneers' Historical Society. Earlier Rounsevell correspondence contains the wartime experiences of Clare, Kate, and Nelson, all of whom volunteered for service. Folders are arranged chronologically by subject.

Series Two, Published Material, 1906-1971, includes published works by Ralph and Thomas Ellinwood, George and Elizabeth Rounsevell, and Nelson Rounsevell. Elizabeth Rounsevell served as editor of the "Women's Department", a column from the socialist publication, "The World". Her published works also include poems, letters to the editor, and articles in newspapers and periodicals, all of which contain her thoughts on socialism and contemporary issues. Items are arranged chronologically by subject.

Series Three, Unpublished Material, contains essays written by Ralph Ellinwood while a student at Columbia. Of particular interest is a piece on Women's suffrage. Elizabeth Rounsevell's writings are in the form of essays, speeches, and diaries. Most are undated. Topics deal with the issues of Progressivism, labor, socialism, and taxation. Both Kate and Nelson Rounsevell wrote down their reminiscences as volunteers during World War I. Folders in the series are arranged by subject.

Series Four, Legal Records, 1892-1916, contains the personal docket of U.S. District Attorney Everett E. Ellinwood and copies of indictments under Acts of Congress, U.S. Penal Code and Revised Statutes. Copies of depositions regarding the expulsion of Navajos from public lands and accompanying correspondence to the Secretary of the Interior and the Commissioner of Indian Affairs are included. Folders are arranged chronologically.

Series Five, Archaeological Expedition Material, 1923-1924, consists of a diary, drawings, photographs and negatives of an archaeological expedition to northern Arizona and Rainbow Bridge, Utah. Ralph Ellinwood, who accompanied a University of Arizona archaeological team, compiled the material. This expedition served as the basis for an Ellinwood manuscript found in Series Three, folder 109. The second half of Ellinwood's diary contains entries on the acquisition of the "Arizona Daily Star".

Series Six, Campaign Material, pertains to Everett E. Ellinwood's unsuccessful bid to defeat incumbent G.W.P. Hunt in the 1926 Democratic gubernatorial primary. Included are photographs of Ellinwood, a newsletter, brochures detailing his platform, and a copy of his final campaign speech.

Series Seven, Miscellaneous Material, 1890-1954. This series contains a broad and varied collection of items that belonged to members of the Ellinwood and Rounsevell families. Among the E.E. Ellinwood material is a 1934 letter from Tucson Mayor Henry O. Jaastad typed on Arizona copper. A citation from the American Field Service, as well as a final exam from Columbia School of Journalism are found in the Ralph Ellinwood folder. Much of the Kate Rounsevell miscellany concerns her work overseas, 1918-1919. Items in this series are arranged chronologically by subject.

Series Nine, Photographs, contains Ellinwood family photos, mostly of Ralph as a young student and his eldest, child Thomas, and Nelson Rounsevell's photos from Nevada, California, Washington, Panama, and Peru. Folders are arranged by subject.

Series Ten, Postcards, consists of items collected by Ralph Ellinwood during his tour of duty in France and reveal the devastating effects of war. Ellinwood's Arizona postcards have been transferred to the Arizona Postcard Collection. Most of the postcards in the Nelson Rounsevell folder are from Central and South America.

Series Eleven, Scrapbook Material, contains newspaper clippings chronicling Everett E. Ellinwood's campaign for governor of Arizona.

Series Twelve, Certificates, contains certificated, diplomas and licenses belonging to Everett, Ralph and Cornelia Ellinwood. Items in this series are arranged chronologically and are housed in Oversize.
