6. Certified Historical Institution (CHI) Grants

- a. Review of FY22 grants and final reports. Jason Mihalic reported the following:
 - All reports are in with the exception of Bisbee Mining and Historical Museum and Cave Creek Museum. Both requested and received extensions for final reports, due 12/31/22. Neither are AHS Small Grants 2022-23 applicants.
 - Sun City Historical Society reported unspent FY22 funds, which will be deducted from FY23 grant funds.
 - Verde Valley Archeology Center reported unspent FY22 funds. They are not a FY23 grantee. Jason will research/propose procedures for unspent funds.

b. Review of FY23 grant applications

- Jason Mihalic reported that the AHS received 23 grant applications from Certified Historical Institution members. All applicants are institutions in good standing (i.e., membership and certification are current). 21 of the 23 applicants (91%) are past CHI grantees, and 2, the Cosanti Foundation and Western Spirit: Scottsdale's Museum of the West, are first time applicants. CHI Small Grants 2022-23 financial request is \$39,128 with most grant applicants requesting the maximum (\$2,000) allowable.
- The Committee reviewed each application for conformity to guidelines, impact
 to community, and alignment with AHS mission and values. The committee
 recommended awarding \$38,491 to all 23 applicants, with two contingencies.
 See Appendix A. Chair Tom Foster will present the recommended slate of
 grant applicants to the AHS Board of directors at the Board Meeting on July
 29, 2022.
