5. Revenue, Expenditures, YTD

- a. Revenue: Still waiting on the July Financial Report from CSB
Expenditures: Still waiting on the July Financial Report from CSB
 - July Financial Report is expected to be delivered by the end of the week. The committee will receive the report via email once received by AHS.
- b. Grants Report shared with the committee
 - Three (3) grants are in process—no other significant updates.
 - Jim Snitzer asked about possible private grants. David Nagelski stated that the possibility of finding private grants is something AHS will look into when the opportunity arises. Currently, there are no private grants available.
 - Private grants can no longer be partially or fully applied towards payrolled positions within State agencies. A State employee will lose benefits if a private grant funds the position.
- c. Development Report shared with the committee
 - The month of July has historically been a low month for fundraising. AHS is gearing up for a fundraising drive in November and December.

6. Announcements and considerations in future board or committee meetings.

- a. The FY26 budget details reveal that the Pioneer funding was included as a Special Line Item (SLI) in the agency's annual appropriations load-out (supporting its restricted nature).

- b. AHS is working on the FY27 budget submittal. It is due on Tuesday, September 2nd. AHS intends to submit the documents by Friday, August 29th.
- c. AHS attended a meeting with ADOA on August 6 to review the agency's FY27 CIP request, totaling \$68.775 million.
