Meeting Minutes

- 1. Call to Order- DeNise Bauer at 9:03 AM
- 2. Roll Call- DeNise Bauer
 - a. Present- DeNise Bauer, Richard Powers, Kelly Corsette
 - b. Absent- N/A
 - c. Staff- Bill Ponder, Jose Rodriquez, Vince Bradley, KD Forgia, David Breeckner
- **3. Minutes** Discussion and action, if any, to approve the draft minutes of the <u>April 10</u>, 2025, meeting. (Richard Powers, Kelly Corsette. Motion approved unanimously.)
- 4. Call to the Public DeNise Bauer
 - a. No members of the public present.
- 5. Tenant Properties & Sites DeNise Bauer
 - a. Site access & work notices
 - DeNise inquired about the timeline for maintenance and repairs, so that AHS
 historical sites and museums can have staff on site to provide access. Jose
 Rodriguez mentioned that many contractors do not have the ability to provide
 a timeline in advance of their arrival, as they are often notified of the work
 service order only 24 hours in advance. Leaving even less time for AHS to
 provide notices of maintenance and repairs to historic sites and museum staff.
- **6. FY26 Facility Planning** David Breeckner
 - a. FY26 budget passed by the Arizona Legislature and the Governor.
 - Includes \$359,700 for 3 years to reopen Pioneer (\$100,000 towards operations and R&M)
 - Includes: site repairs, technology refreshes, new equipment, etc

- FY26 CIP has not yet been announced.
- b. \$279,000 planned toward facility R&M in FY26, including:
 - AHC Pavilion Risk Management Roof repair. Phase 1 complete. Phase 2 is the mold mitigation and drywall repair.
 - AHC & AHM exterior Structural repairs.
 - AHC HVAC system services across the entire building.
 - AHC HVAC upgrade AHU 9 & 11 postponed to December-January timeframe.
 - Across AHS Mold Mitigation & Prevention

7. FY27 Facility Planning - David Breeckner

- a. FY27 CIP under final development.
 - Similar to FY26 CIP request: **\$66m** in new development, **\$3.03m** in repairs
- b. FY27 Agency budget under final development, to be approved by Board on 7/25/25.
 - Requesting R&M budget of \$450,000 (\$171,000 increase)
- **8. Announcements** and considerations in future board or committee meetings.
 - a. Update on progress of new Tucson building site.
 - Bill Ponder- Conversations continue with council representatives and stakeholders. Council representatives have stated that AHS will be kept in the conversations as it progresses forward.
- **9. Adjournment-** DeNise Bauer adjourned the meeting at 9:39 AM
